Protocol Review and Updates (Nick Harrison)

- 24 of the protocols will remain unchanged
- Due to the large amount of alterations done by the state a protocol review committee will be put together to review them more thoroughly; such as the Adult Cardiology which had a lot of changes.
- If you are interested in being involved with this protocol committee and would like to be a part of it please contact Nick Harrison.
- In February 2023 our Medical Control will be officially adopting these protocols.

(PCI) Primary Percutaneous Coronary Intervention– (Rebecca Boyce & Renee Lamp)

- Currently Alpena only performs procedures for diagnostic purposes, but does not have the ability to perform for intervention.
- For every 10 minute delay results in 3.31 deaths per 100 PCI patients.
- The closest facility with PCI capability is 111 minutes from Alpena.
- Time is tissue, and according to AHA the recommended time frame for an artery to be reopened is 90 minutes.

WHY ALPENA?

- Will give timely access that will meet the recommended timeframe for the Alpena area and surrounding areas.
- Decrease mortality rate, lower the risk of progression to heart attack, and reduce the susceptibility for complications such as cerebral bleeds.

TIMELINE FOR SERVICE / TASKS TO COMPLETE

- State approved application of service needed Sept 1, 2022
- Projected for January 31, 2023
- Go live date was originally April 1, 2023 but may be pushed to June 1, 2023
- Need Workgroup established
- Education will start the 1st of the year

CARDIO SOLUTIONS “TRAIN THE TRAINERS”

- CE Credit Approved trainings will be available to the local people at each agency.

- Tweak and adopt the Mid/Glad STEMI Protocol and get it approved by the State.
- Cath Lab 30 min call in time.
- Heparin (weight based dose, not drip) will eventually be added to drug box.

- The EMS supply room that we share with hospital staff is now going to be primarily an office space. The drug box cabinet is temporarily in the hallway, and the IV supplies are in the cleaning supplies room.
- Currently looking for a new permanent home for EMS Supplies
